Mayor Eric Ferguson called the regular meeting to order at 7:00 p.m.

Call to ORDER

Friend moved, and Baker seconded the motion to approve the May regular meeting Vote was 5/0, motion carried.

Visitors:

Several Lebo area citizens, PWWSD #12 board member Brandon Smith, and County Commissioners Todd Barker and Wayde Thomsen, were in attendance for the Lebo Lake Dam renovation discussion. Mayor Ferguson informed the public that the council did not have plans to vote on draining the lake, as many citizens had heard. He explained that the city council planned to discuss the dam renovation project with Ben Kramer, Kramer Consulting. Kramer Consulting who has been working on the state-required Plans and Specs for the dam. Due to the large number of attendees, Mayor Ferguson announced he would open the floor for comments and asked the public to limit their comments to 2 minutes. A few comments were made expressing support for repairing the dam. Joe Shoemaker again voiced his opinion about draining the lake to allow for new housing around the lake area. Kramer explained that the Plans and Specs to renovate the entire dam area are almost complete and ready to send to the State for approval. Hopkins moved and Friend seconded to hold a special meeting on Monday, June 16th at 7 pm to meet with Kramer to discuss the Plans and Specs for the dam. Also on the special meeting agenda will be the 2026 budget preliminary discussion. Vote 5/0, motion carried.

C Lake Dam

Brandon, Public Wholesale Water Supply District 12 operator, was present to discuss the advantages of the GSI mapping for the water and sewer systems. Mapping is available through KRWA. Muro provided in the council packets pricing proposals from KRWA. Discussion on the matter will be added to the 2026 budget.

Muro asked the council about the road easements in town that remain undeveloped but now have houses located past the existing pavement: Sycamore Street north of 5th St., Walnut south of College St., and Cedar St. south of 2nd Street. Discussion was held about the private road on the Murphy's Elevator property. The property is within the city limits, the entrance to the property

off of South Ogden is a railroad right-of-way, after that, it becomes a private road to the city limits. Hopkins moved and Sanchez seconded to table discussion on road improvements until budget discussion. Vote 5/0, motion carried.

Baker moved and Friend seconded to approve Muro's request to purchase the Vermeer EVT1002, EV 150 Trailer EV150GT, 3500 GVWR, 1X40 Gallon water tank for \$38,730 with funding coming from the city's non-budgeted Equipment Reserve Fund. Vote 5/0, motion carried.
