Becky Nurnberg, Emporia Community Foundation presented a \$30,000 check from the Trusler Foundation. Lebo Park and Recreation board member Jenny Tatman had submitted a grant request for \$30,000 to help with the expenses to replace the playground equipment at the west park.

Mayor Ferguson opened bids on the natural gas system: Kansas Gas Service-Division of One Gas - \$1,000,000 Black Hills Energy - \$622,050.00

Mayor Ferguson opened the floor for discussion on the bids:

Sean Postlethwait, Susan Marx and Lindsay Freeman were present for Kansas Gas Service they spoke about their company and the fact that two of their employees live in Lebo and they would like the opportunity to service the Lebo area, they serve several communities in the area.

Larry Claycomb was present for Black Hills Energy, he pointed out Black Hills has assisted and supported the city and its employees with the maintenance of gas system for a couple years now. They know the city gas system and would like to continue to work with the city.

Visitors:

Ben Kramer and Andrew Fischer, Kramer Consulting LLC presented an overview of the state required dam inspection. After the submission of the inspection report the city received a letter from the Kansas Department of Agriculture stating the city is required to hire a licensed professional engineer in dam design and construction to submit plans to DWR to

modify the dam to bring it back into compliance with all applicable state statues and regulations. Kramer's report indicated there are 5 items that need immediate attention, 10 items of general maintenance to address and 2 other items of other actions the city should consider. The council asked Kramer to attend the October meeting with a contract proposal for services and an estimate of probable cost to bring the dam back into compliance.

Wayne Blackbourn reported on the availability and probable cost of utilities for the Sun Flower Cartel proposed Sub Division. Blackbourn's estimated cost are based on current similar construction cost in Waverly and Emporia. Sewer - \$932,992, Water - \$433,470 and Streets - \$998,844. The city zoning regulations for Subdivisions require the council to determine if water and sewer is available. Based on Blackbourn's report sewer and water are available. The next step is for the Sun Flower Cartel to present a preliminary plat to the zoning administrator who shall schedule a public hearing with the planning commission.
