Mayor Ferguson called the regular meeting to order at 7:00 p.m.

Joe Shoemaker was present to voice his discontent toward the city selling the natural gas system. He feels it is not in the city's best interest to sell the system. He is concerned that the price of natural gas will increase. It was explained that if the council decides to proceed further it will take several months and the public will vote on the sale. The next steps would be: Send out a request for bids on the system. If the council finds those bids are acceptable council will need to pass an ordinance notifying the citizens of the city's intent to sell the gas system, then public hearings will be held, then there will be a special question in an election posing the question to the citizen for the approval of the sale.

Police Report - Arron Cathcard - written report in packet

Cathcard discussed with the council the advantages of the city partnering with the Coffey County Sheriff Department to use Celebrite. The cost for the county to obtain the system and get training was \$20,000. There is a \$10,000 a year subscription for the online services for the device. Celebrite is an advanced forensic examination tool for cellphones to help recover evidence. The Sheriff Department is proposing an annual fee of \$1,200 from local law enforcement agencies to help defray the cost of the annual \$10,000 subscription. Cathcard has room in his budget for the \$1200 cost and will enter into an agreement to share in the annual cost of the subscription. Council will add the \$1200 to the annual general fund budget (line item law enforcement).

Clerks Report -- Carrie Sloan

- Finances: clerk's cash report, bank balances and sales tax
- Kramer has completed Dam inspection report waiting on the state review
- Sloan asked about getting the old firehouse/police station cleaned out so that bids can be acquired for the demolition.
- The city will be receiving two checks from EMC insurance. Payroll audit refund of \$1,172 and safety group dividend of \$9,164.63
- The total cost to replace the old bathroom at the west park to a CTX concrete vault bathroom is around \$58,000. Sloan has applied for two grants to assist in funding the project.
- The city auditor will be in this month to complete the 2022 audit and work on the 2024 budget
- Sloan suggested the city gather up unused items/equipment and contact Gavel Roads about another online auction
- If the council is interested in selling the gas system bid request on the system should be sent out soon because the procedure to sale the system will take 5 or more months. If the sale is approved this will align with the city's fix gas price contract ending with Encore.
- On June 1st the city will receive a payment of about \$73,000 in property tax from the county treasurer's office and a \$40,000 sales tax payment from the state treasurer's office. Sloan feels there is an error (approximately \$12,000 from Beto) in sales taxes collected that will need to be refunded.
- 9th Payment to Hartford Bank was made on the Lease Agreement for the downtown streetscape funding
